Telemental health sub-committee has cancelled the June 26th scheduled meeting because of a webinar - **Friday, June 26, 2015, 9:00 AM to 5:15** Kansas Psychological Association Webinar: *Adventures on the Electronic Frontier: Ethics and Risk Management in the Digital Era* This webinar gives participants a means to evaluate risks, benefits, and appropriateness of using various electronic communication and social networking media in professional practice; and to potentially utilize good risk management strategies in the provision of remote professional services. Marcia reported on two more agencies that she spoke with: St. Francis Community Services does NOT use any telemental health technology and High Plains Mental Health Does use telemental health technology. Marilyn was asked to maintain a list of facilities and links that could be resources for telemental health technology question in the future. We need to keep a running master list of websites and links concerning this issue.
