Re: Report of the February 2, 2024, Meeting of the Joint Committee on Administrative Rules and Regulations

With this report, the Joint Committee on Administrative Rules and Regulations provides its comments on rules and regulations reviewed at its meeting on February 2, 2024. Agencies are asked to respond to each comment or request for information; responses are compiled and maintained by staff of the Kansas Legislative Research Department.

General Comments

The Committee notes long development, drafting, and approval times for many proposed rules and regulations, especially those rules and regulations required by enacted legislation, and welcomes suggestions for process improvement.

The Committee requests terms be standardized across agency regulations, to the extent practicable, such as terms used to describe online learning and continuing education courses for state-licensed professionals.

The Committee asks why the term “substance use” was removed from paragraph (c)(2) and replaced with “biopsychosocial needs.” The Committee expresses its concern that the modification of this educational requirement may result in students completing less coursework specific to addiction and substance use.

KAR 30-47-816. The Committee requests the agency reference the requirements of KSA 8-1344 regarding appropriate types of child safety restraints during transportation based on age and size in subsection (c).

The Committee requests information on whether determinations regarding whether a child is in need of care or payments for children in need of care with an undocumented immigration status differ from those for children who are citizens and the legal basis for treating the groups the same or differently.

KAR 26-52-15. The Committee requests the agency consider replacing “or” in subsection (d) with “and” to ensure the treatment plan is reviewed at least daily and at the conclusion of the patient’s stay.

KAR 26-52-19. The Committee requests the agency consider moving requirements for testing for tuberculosis from this rule and regulation to KAR 26-52-22, infection control, COVID-19 protections.

The Committee suggests the Legislature review the statement of patient rights in KSA 59-2978, which is applicable to various types of facilities overseen by this agency.
