**DRAFT Minutes**

- I. Call to Order.** Linda Heitzman-Powell, Chair of the Advisory Committee, called the meeting to order at 1 p.m.

- II. Additions to the Agenda and Agenda Approval.** Christine Marie Stiehl moved to approve the agenda. Allyson Bell seconded. The motion passed.

For question 12, Advisory Committee members supported rewording the question to note that the Board is seeking to add a 13th member to the Board, so there be a board member for the behavior analysis profession, and the new language would ask licensees to provide their thoughts on the proposed action by the Board. Advisory Committee members recommended changes to question 8 to state, "In a typical week, how many hours are you providing face-to-face clinical services to clients?" The Advisory Committee also added questions asking, "How many hours per week of clinical services are you overseeing/managing?" and "Do you maintain an active license, but no longer working as a behavior analyst?" Advisory Committee members also revised the question pertaining to a multi-state compact. The Executive Director asked Advisory Committee members to contact him directly, rather than in a group message, if they had any additional thoughts or recommended edits to questions.
