

**Behavioral Sciences Regulatory Board
Master's Level Psychology Advisory Committee Meeting
April 2, 2025**

Approved Minutes

- I. Call to Order.** The meeting was called to order by David Anderson, Chair of the Advisory Committee, at 1:00 p.m.
- Master's Level Psychology Advisory Committee Members.** Advisory Committee Members who participated by Zoom or phone were David Anderson, Ginger Hill, Rebecca Jabara, Lauren Lucht, Sarah McMillen, Iris Pauly, Jennifer Schreiner, Joshua Tanguay, and Kari Wold. David Stevens, Bruce Johnson, and Robert Pedroza were absent.
- BSRB Staff.** BSRB staff members who participated by Zoom included David Fye.
- II. Approval of the Agenda or Additions to the Agenda.** Kari Wold moved to approve the agenda. Joshua Tanguay seconded. The motion passed.
- III. Review and Approval of Minutes from Advisory Committee Meeting on February 7, 2025.** Kari Wold moved to approve the minutes from the Advisory Committee meeting on December 4, 2024. Ginger Hill seconded. The motion passed.
- IV. Executive Director's Report.** The Executive Director reported on agency operations, legislative updates, recent Board meetings, and upcoming meetings.
- V. Old Business.**
- A. Continued Discussion on Regulation of Artificial Intelligence (AI).** The Board has asked Advisory Committees to review artificial intelligence (AI) and its potential use(s) in behavioral health practice. At the last Advisory Committee meeting, the Executive Director provided documents to Advisory Committee members to review concerning this topic. The Executive Director informed Advisory Committee members that if they know of any experts on AI who could speak to the Advisory Committee, he would be willing to invite them to present at a future meeting. This agenda topic will be carried forward for additional discussion at future meetings.
 - B. Continued Discussion on Adding a Description of Each Profession to the BSRB Website to Inform Public of the Differences Between the Professions.** Iris Pauly and Kari Wold previously agreed to draft language for this item. In reviewing the proposed draft language, Advisory Committee members supported replacing the term “doctoral level clinician” with “independently licensed clinicians.” The Advisory Committee also expressed support in differentiating what license types can practice independently and which cannot. Advisory

Committee members viewed these descriptions from a public standpoint, wanting to ensure that the language is easily understandable for people not working in the field of mental health. The Executive Director is going to make updates to this language and bring it back to the next meeting for review.

VI. New Business

A. Review and Discuss DRAFT Survey Report on LMLPs and LCPs. The Executive Director presented a draft survey report to the members of the Advisory Committee. When the survey period was closed, 236 LMLPs and 123 LCPs completed the survey. The Advisory Committee reviewed the draft survey results and discussed the findings. One topic that particularly stood out to Advisory Committee members was the concept of people being able to get clinical licensure after being licensed after a certain number of years. Advisory Committee members also discussed the validity of the licensing examination and whether passing/failing the EPPP should single-handedly determine an individual's competency to practice. The Executive Director noted the agency's goal is to have the final version of these survey reports posted to the publications section of the BSRB website within the next month.

B. Discussion on Possible Topics for 2025. No additional topics were added.
